

Soundholder END USER LICENSE AGREEMENT

The end user license agreement (the "Agreement") is entered into between you, a single user person (the "Licensee" or "You"), and (soundholder or "Licensor") the owner of "Sound Effect Libraries" or "Libraries" or "Sounds". For multi-user license, please contact at contact@soundholder.com.

The Licensor is the creator and owner of the "Sound Effects Libraries" or "Libraries" or "Sounds" that are listed on the invoice which the Licensee receives after the purchase.

This Agreement covers one or more sound libraries purchased by the Licensee via the soundholder.

In consideration for the purchase of the Sound Effect Libraries via soundholder, the Licensor grants the Licensee a perpetual, royalty free and worldwide license to use the sounds in the Sound Effect Libraries ("Sounds") on the terms and conditions set out in this End User Licence Agreement.

Please read the terms carefully before purchasing the Sound Effect Libraries. By purchasing, you (the "Licensee") acknowledge that you have read this agreement, and you understand it and agree to be bound by its terms and conditions.

1. THE LICENSE INCLUDES

- **a.** The right to use Sound Effect Libraries on one workstation at the time. The Licensee is allowed to keep backup copies of Libraries on other storage devices.
- **b.** The right to use Libraries as a soundtrack synchronised with any kind of visual images, or as a part of Your or Your clients media production/product.
- **c.** The right to use the Libraries as apart of public viewing or broadcast of Your or Your clients media production/product.
- **d.** The right to edit, re-record, duplicate and release the Libraries as a part of Your or Yours clients media production/product.
- **e.** The right to use the Libraries as individual sounds in video games, apps and any kind of media productions.
- **f.** The right to transfer the Libraries to any medium to complete media production/product.

2. RESTRICTIONS

- **a.** The Licensee is not allowed to distribute or perform Sounds or reproduction of the Sounds which are not incorporated in and synchronised with other media productions.
- **b.** Libraries may not be exploited or traded for profit or any other reason except as permitted in Clause 1.

- **c.** Licensee may not claim ownership or authorship of Sound Effect Libraries or Sounds represented under this Agreement.
- **d.** Licensee may not transfer, copy or sell Sound Effect Libraries or Sounds bought via soundholder on stand-alone basis to any other individual or party, except as permitted in Clause 1.
- **e.** Licensee may not sell hard drives or discs or any other electronic storage media which contain soundholder Sound Effect Libraries or Sounds.

3. INTELLECTUAL PROPERTY RIGHTS

The Licensee may not claim ownership or authorship of the Sound Effect Libraries or Sounds. Licensor maintains all intellectual property rights with regard to the marketing and sales of all Sound Effect Libraries, and any infringement thereof is punishable by the law.

4. LIABILITY

Licensor is not liable for any damages or loss of business interruption, business profits, or any other direct or indirect loss resulting directly or indirectly from the use of any of Licensor's Sound Effect Libraries or Sounds.

5. TERMINATION

The Licensee's rights will automatically terminate in the event of any violation of the terms of this Agreement. In the event of termination, the Licensee shall destroy or delete all copies of the Sound Effect Libraries or Sounds which the Licensee has produced.

6. INDEMNITY

The Licensee will indemnify Licensor from, and against any and all claims, demands, awards, damages, sues, liabilities, injuries and all expenses, including attorney's fees incurred by the Licensor with respect to any matter that arises, as a result of a breach or alleged breach of this Agreement by the Licensee.

7. WARRANTY

Licensor warrants that Your use of Sound Effect Libraries or Sounds does not infringe on any third party property and / or proprietary rights.

8. TERM

This Agreement commences on the date of purchase and is effective in perpetuity.

9. GOVERNING LAW

This Agreement is governed by the law of Poland. You agree for exclusive jurisdiction for any action relating to this License Agreement.
