Information about you: how we use it and with whom we share it

We will use your personal data to allow us to process your registration for the event and to communicate with you and obtain your feedback about the event. We will not share information about you with any other third party. We will hold the personal data you provided us for 6 months. We do not use profiling or automated decision-making processes.
